The Ordinary Business of the AGM will be:

- Pass minutes from 2016 AGM
- Receive the SPBA Annual Report
- Receive the audited statement of accounts for the year 2016/2017
- Table any business items received prior to the closing date
- Conduct the election of the 5 board member positions

Failure by teams to have at least one representative attend the Annual General Meeting will incur 3-premiership point loss (except in the case of clubs).

Attendees to the Annual General Meeting can only sign in for one team.

A club is defined as more than 3 teams governed by one body with a duly elected secretary. In the case of clubs, the number of representatives required to attend the Annual General Meeting must equal at least 50% of the number of teams in that club.

Failure by a club to do so will also incur a 1-premiership point loss to all associated teams in the Summer 2018 season.
